Slippery Rock Borough Council convened this date at the Slippery Rock Borough Building located at 306 East Water Street, Slippery Rock Borough, Butler County, Pennsylvania. The meeting was called to order at 7:00 p.m. followed by the Pledge of Allegiance.

Slippery Rock Development – Ron Steele reported they are still working on the street light poles and the benches and trash receptacles that were repainted are back.
